AHF executes contract of sale for Drumborg Farm

Australian Dairy Nutritionals Group (**AHF or Group**) advises that it has today, entered into a contract of sale for the Drumborg farm located at 20 Sinclair Road, Drumborg, Victoria. The sale includes the land and dairy for \$6 million plus livestock and associated equipment (subject to valuation prior to settlement). The purchaser is required to pay a 10% deposit, \$60,000 payable on execution of the sale contract and the balance (\$540,000) when the contract becomes unconditional.

The sale contract is conditional on the purchaser obtaining finance to fund the purchase, which must be obtained within 28 days from the date of execution of the sale contract. Provided the purchaser successfully obtains funding for the purchase, settlement of the sale is due to occur on 29 January 2021. The Board is pleased with the sale price for the Drumborg farm and believe it reflects the strong demand for quality dairy farms in South West Victoria.

The Board decided to sell the Drumborg farm as the milk produced by this farm is surplus to the Group's production requirements (both now and following commissioning of the Stage 1 infant formula plant) and, unlike the other Group farms, is located a significant distance (approximately 2 hours) from the Group's manufacturing operations in Camperdown, Victoria.

The sale proceeds will be used to strengthen the balance sheet by repaying part of the Group's debt facility. The A2 beta casein only producing livestock (**A2 cows**) currently on the Drumborg farm are not included in the sale and will be relocated to the Group's remaining farms close to Camperdown. When these farms achieve organic certification, the A2 cows will also be producing organic A2 milk.
