Quarterly Activities Report for the period ending 31 December 2021

Austpac Resources NL (Austpac or the Company) (ASX: APG) is pleased to provide an update on its quarterly activities for the period ending 31 December 2021.

The Company is currently in voluntary suspension. Refer to the company's ASX announcement on the 17th of June 2021. The suspension will remain in force pending the satisfactory resolution of ASX's queries in relation to certain prior issues of securities that occurred in the period between 2016 and 2019 and other Listing Rule matters.

The Company's primary activities for the reporting period were:

- Finalising an application to the Federal Court to seek declaratory relief in relation to certain prior share issues that occurred in the period between 2016 and 2019.
- Contracting an environmental consulting company to prepare a preliminary environmental assessment report regarding the Company's Kooragang Island site. This report was requested by the EPA. The report was completed in December 2021 and sent to the EPA for their review in January 2022.
- Continuing discussions with steel mills to finance and construct a pilot plant to assess the ZIRP technology's applicability for their steel mill waste stream.
- Continuing discussions with an overseas company interested in assisting the Company to advance the development of the Company's ZIRP technology;
- Pursuing an agreement to raise funds to pursue new opportunities which complement its current line of activities.

Voluntary Suspension from the Australian Stock Exchange

As noted above, Austpac Resources entered into voluntary suspension of trading of its securities on the 17th of June 2021 pending the satisfactory resolution of queries from the ASX in relation to certain prior issues of securities by the Company that occurred in the period between 2016 and 2019.

The Company released an update on the status of the voluntary suspension on the 30th of July 2021 (see ASX announcement "*Update on Suspension from Official Quotation*") and further commentary on its Quarterly Activities Report for the period ending 30 September 2021.

The Company expects to lodge an application in the Federal Court within the next month to seek declaratory relief in relation to historical share issues that occurred during the period 2016 to 2019.

Austpac Completes environmental report for the EPA.

Prior to Austpac resources completing the closure of the Newcastle site, it was required to complete a preliminary assessment report. This report was completed in December 2021 and lodged with the EPA in January 2022.

Zinc Iron Recovery Process (ZIRP)

The Company demonstrated last year that its ZIRP technology is capable of producing a quality zinc oxide and iron product from steel industry waste products.

The Company has conducted a review of its technology and has worked through a process where acid regeneration was taken out of the process. This was due to enquiries from companies who were specifically looking for recovery of iron and zinc without the need for treating spent pickle liquor. This review was completed and a paper was prepared by the Company for presentation to potential steel mills.

Using the above approach, Bench Scale test work was completed on a sample of EAF (Electric Arc Furnace) dust supplied by one of the steel mills. This test work was successful and a report has been provided to the mill for review and further discussion.



Austpac Resources remains in discussions with a couple of local companies and an overseas company who are investigating the potential use of the ZIRP technology within their market.

As noted last quarter the Company closed its ZIRP facility at Kooragang Island, Newcastle, on the basis that a new site with new equipment closer to the feed source is required to prove the process at a commercial scale. The Company also concluded that a partner who can work hand in hand with the Company may be the solution to fast track the commercialisation of the technology.

Nhill Exploration - EL 5291

There was no exploration undertaken by the Company on EL 5291 during the quarter.

Corporate

- Cash at the end of the quarter was \$41,000 (of which \$29,000 is bank guarantees).
- During the quarter, the Company received an additional loan facility of \$200,000 from Kore Management Services P/L ("Second Loan Facility"), of which the Company's non-executive chairman, Mr T Cuthbertson has an interest. The two

loan facilities total \$400,000. During the quarter, the final \$55,000 was drawn on the first \$200,000 facility. (Full details are provided in the Appendix 5B).

- The Second Loan Facility is unsecured loan with 12% interest per annum. Penalty interest of 15% per annum will apply on the outstanding loan amount in the event of default. The loan with interest is to be repaid, at the earlier of:
 - After 12 months from the date of each drawdown; and
 - If there is a change in management and directors and the Lender does not agree with those changes.
- At the end of the quarter, the unused loan facility available to the Company was \$200,000.
- Cash used in operating activities during the guarter was \$65,000.
- No payments were made to related parties of the Company during the quarter.
- The Company's new registered office is Level 1 283 Pitt Street Sydney NSW 2000.
